Castel San Vincenzo is an Italian town of 501 inhabitants in the province of Isernia in Molise. It is the most important municipality of Molise in the National Park of Abruzzo, Lazio and Molise. On its territory there are the famous abbey of San Vincenzo al Volturno and the lake of Castel San Vincenzo, an artificial basin built in the late fifties for hydroelectric purposes. The lake occupies an area of 6.140 km² and has a useful capacity of 10 million cubic meters. Although artificial, the lake is well harmonized with the surrounding landscape and represents an environment of particular beauty along with the Mainarde mountain range. The territory preserves traces of an agricultural village of late Roman times and an oratory dedicated to San Vincenzo dating back to the period between the fifth and sixth centuries.

Between the 7th and 8th centuries a Benedictine monastery was built there and it is believed that in the first half of the 9th century the monastic complex of San Vincenzo was one of the most important in Europe.

The Municipality is very active in the initiatives of territorial development and promotion of sustainable tourism. In fact, the municipal administration participates in various projects to promote the cultural, historical and environmental wealth of the country.


