**The Municipality of Larino is a territorial public body that represent, care and promotes the economic growth and the cultural and social development of his own community. It has a population of about 6700 inhabitants and is located near the Adriatic Sea, in Molise Region.**

**The staff is composed by: The Mayor; the “Giunta Comunale”; the “Consiglio Comunale”. The most important offices are: “Economic and Productive Affairs” office; “Public Works” office; “Financial” office; “Cultural Department”; “Town Planning and Environment” office.**

**It was founded in the pre-roman period by the Frentani people. During the roman period it became an important city with the presence of the Forum, the thermal baths and the amphitheatre, which ruins are nowadays visitables, together with polychromatic mosaics (now conserved in the Civic Museum).**

**The most important monuments are the Cathedral of San Pardo (consecrated in 1319) and the Ducal Palace of medieval origins (the seat of Municipal Hall).**

**Between ancient and economic activities it organize the “Fiera di Ottobre”, an important fair in which are involved a lot of producers by the main Italian Regions.**

**Every year, from 25 to 27 May, takes place the “Carrese of San Pardo”, a procession of over one hundred of decorated carts pulled by oxen.**
